**WAIVER, RELEASE AND ASSUMPTION OF RISK AGREEMENT**

Please read carefully before signing.

This is a release of liability and waiver of certain legal rights.

This signed form covers the length of the membership period.

In consideration for my being permitted to participate in the activities of Golden North Archery Association, I agree to the following Waiver, Release and Assumption of Risk :

I acknowledge that archery has inherent risks, hazards, and dangers for anyone, that cannot be eliminated, particularly in a wilderness environment. I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION but are not limited to the following:

1. The risk of archery equipment and being near others that have archery equipment in their possession and engaging in archery activities;
2. The risk of injury from arrows shot from other bows;
3. Walking, shooting, searching and pulling arrows on marginally developed trails and in rugged country,including encounters with wildlife, animals/ insects;
4. Inclement weather conditions.
5. The risk of range maintenance equipment and being near others that are using range maintenance equipment.

I understand the risks, hazards, and dangers as described above and have had the opportunity to discuss them with Golden North Archery Association Officials. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks. I AM VOLUNTARILY USING THE SERVICES and FACILITIES OF Golden North Archery Association WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH.

Lastly, I, for myself, my heirs, successors, executors, and subrogees, hereby ASSUME ALL INHERANT RISKS AND KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS Golden North Archery Association, their directors, officers, agents, and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorneys' fees) which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to, NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my engaging in these activities or the use of these services, animals or equipment, whether such damage, loss, injury, paralysis, or death results from negligence of Golden North Archery Association or from some other cause. I, for myself, my heirs, my successors, executors, and subrogees, further agree not to sue Golden North Archery Association as a result of any injury, paralysis, or death suffered in connection with my use and participation in the activities of Golden North Archery Association.
